Executive Director

Mr. Haas reported that Esker Square continues preleasing for Building 2. He has met three times with potential investors for the Cedar Corridor. Mr. Haas stated that 2142 Cedar Street will be occupied until the end of December, then demolition will be dependent upon the utility companies and their demolition of the water, electric, and gas utilities. Mr. Haas reported he has inquired about a proposal from The Chesapeake Group to look at housing and population trends for the Holt area.

Advertising & Marketing Committee

Mr. Leighton reported that the Advertising and Marketing Committee met on six agenda items on November 28, 2024. He reported that with the transition of Blohm Creative Partners to Truscott Rossman it was discovered the DDA has several web domains that may benefit by being consolidated. The Committee discussed how to consolidate domains without losing identity and being inclusive of other Delhi Township and Holt entities. Mr. Leighton discussed the Truscott Rossman's presentation of an updated Downtown Development Authority's Value Piece. Mr. Leighton presented the Board with the Farmers Market Facebook November Report on demographics. Mr. Haas expressed the desire to draw in a younger crowd with different platforms. Mr. Haas stated he would like the DDA websites to bridge the understanding of what constitutes Holt and Delhi Township.

In the absence of the Treasurer, Ms. Rae, Mr. Haas reported that the total DDA cash and investments as of October 31, 2023, totaled \$7,161,650. He stated he would be giving a Meeder Investments report in January.

- Construction completed on Building 1 at Esker Square; Building 2 is pre-leasing. The
 Esker Square project will provide the Cedar Street Corridor with 90 apartments with first
 floor live/work units available.
- Property purchased at 2361 Cedar Street, 2221 Cedar Street, and 2224 Aurelius Road for redevelopment. Buildings have been demolished.
- Property purchased at 2142 Cedar Street immediately adjacent to the Holt Farmer's Market will be utilized for additional Farmers Market space and parking.
- The Holt Farmers Market have been hosting its popular Food Frenzy, and BBQ and Brew events this summer and fall. Food trucks and live entertainment brought thousands of Delhi Township residents and visitors to the Cedar Street corridor. The Holt Farmers Market continues to expand.
- Operation of Holt Farmers Market, one of the Township's most popular destinations continues to expand. SNAP (EBT), Double Up Food Bucks, Senior and WIC Project FRESH coupons accepted.
- Quarterly Newsletter HoltNow published highlighting local businesses. Continued expansion of social media outlets (Facebook, Twitter, and Instagram) highlight Township events and local businesses.
- The Non-motorized trail between Holt and Mason is under construction in conjunction with the re-surfacing of Cedar Street, completion is expected by summer 2024.

The market maintained regular Saturday market hours from 9:00 to 2:00 for 2023. Between 16 and 35 vendors participated in these markets, depending on the season. These numbers include some food trucks and trailers. There were many new faces at most every market – in addition to our regular, loyal customer base. The average attendance ranged from 300 to 600 throughout the year.

2023 token sales numbers were up, with debit/credit token sales reaching \$15,499 – a 41% increase from the 2022. EBT (Bridge Card) token sales were up slightly at \$9,387.

Holt Farmers Market participated in the "Double Up" program (DUFB). This program allows EBT/SNAP customers to double their fruit and vegetable purchasing power, and allows those customers to spend their regular EBT/SNAP dollars on other products not covered by the DUFB program. DUFB token sales remained about the same from the previous year.

The Holt Farmers Market again participated in WIC and Senior Project Fresh between June and October. These programs are administered by the county and are designed to encourage WIC recipients and seniors to buy fresh produce as part of a healthy diet.

Returning anchor vendors included Great Harvest Bakery, Lonesome Pines Beef, Otto's Poultry, Rowes Farm Market, Willow Blossom Farms. Several other vendors returned offering ready-to-eat, baked goods, take & bake items, etc.

Notable for 2023

- As in years past, the market was again happy to accommodate the Girl Scouts (cookies) and Boy Scouts (popcorn) for some of their annual fundraising.
- New this year, the market welcomed Michigan Leader Dogs for the Blind on several Saturdays while the market was open, and for a special training at the market on a Sunday. This training program is currently preparing approximately 16 dogs to be placed with people visually impaired once their training is completed.
- Seven Food Frenzys were held from April through October and sponsorships amounted to \$6,500. A big thank you to the Lions Club for providing some volunteers to help teardown after the Food Frenzys— like they have done for the past few years.
- The "Cruise-In" car shows were held every Friday from July through September at the market and were very well attended a couple of these shows reached capacity. The car shows were organized and facilitated by Evan Hope.
- The first Holt BBQ & Brew was held at the market on Thursday, August 31st and was very well attended. This event featured BBQ food trucks, a craft beer tent for those 21+ and live music. Two Holt BBQ & Brew events will be scheduled for 2024.
- A new digital sign was installed during 2023. Based on customers commenting on the sign and the information it displays, it seems to be doing a great job of showing a few samples of what can be found inside the market, hours of operation, etc. The sign was also used to promote the Holt Food Frenzy's, the Cruise'In Car Shows, and the first Holt Brew & BBQ event.

2023 Inventory

An inventory of items located at the HFM is attached part of this summary, and are considered the property of the Delhi Township Downtown Development Authority. This inventory does not include decorative items, farmer-owned tables, and coolers. See Pages 3 and 4 for detailed inventory.

Growing Pains

The Holt Farmers Market continues to meet our objectives of exposing the community to locally grown and produced food, while simultaneously providing an excellent way for local vendors to showcase their products.

New food-related (greens, mushrooms, jams/jellies, sauces, candy, etc.) vendors are added frequently – limited only by the market space available to accommodate them. Many of these vendors request an every-other-week presence; some are interested in coming once a month. Every effort is made to introduce as many of these vendors to our customers as possible.

Based on the number of vendors we retain, as well as the new vendor applications received nearly every week, it is clear the Holt Farmers Market has become a "preferred" vendor destination. The Holt Farmers Market is proud of this achievement, even though scheduling and finding space for all the vendors who want to be at the market continues to be a challenge.
