#### **Executive Director**

Executive Director Howard Haas reports that the intended sale of 4410 Holt Rd (Holt Community Center) is moving forward with plans of purchase to be made by Family and Lifestyle Medicine LLC,

which includes three Medical Doctors. If finalized, a Buy-Sell will be created by the DDA's attorneys at Thrun, which would be presented to the DDA Board in July, Haas states that the DDA plans to move their office into the new Farmers Market annex building. This requires the original 40x60 plans to be increased to a 40x80 layout. Haas states that unfortunately architectural plans have been slowed due to the passing of our original Architect. Roger Donaldson will be taking over for the remainder of this project. Additional costs are expected due to change with the dimensions. The combined sale of the Community Center and the grant of \$175,000 to the DDA via LEAP, (Lansing Economic Area Partnership) the additional costs will be covered. Mr. Haas reports that the Elkhorn Pass development located on the corner of College and Holt Rd will hold one-hundred and fifty-seven rental homes, and have three-, four-, and five-bedroom options. The construction will be two phases over the course of four years. The State of Michigan has changed its regulations, which now allows developers recovery through the Brownfield Redevelopment Authority. In other news, the repairs to local restaurant El Burrito have been slow due to the antique tiling that had to be created. The DDA has ordered two solar flood lights that are currently being shipped to light up the Welcome to Holt sign. The paving of the Farmers Market parking lot, which was approved at last month's Board Meeting, is set for the last week in July. The signing of a second amendment to the Brownfield project #4, Esker Square, has taken place due to original ownership selling. Lastly, Mr. Haas reports that there is still ongoing discussion with Advanced Redevelopment Solutions and will provide updates as available.

#### Advertising & Marketing Committee

Executive Director Howard Haas substituted for David Leighton, who was unable to attend today's Advertising and Marketing meeting.

Mr. Haas states that at today's meeting, Truscott Rossman reports that the DDA's and Farmers Market advertising is steadily increasing each month, with a total of 1.8 million impressions across a 20-mile radius of Holt. 571,000 of those impressions come from ages ranging 18-45, while the remaining 613,000 came from ages 45-65+. There is a total of 223,000 responses to events and advertisements, which is a 58% increase since last year.

#### **Planning Commission**

Rita Craig shares that a re-zoning request for Maxima by the railroad between Depot St and Woodland Lakes has been made and approved. Fauser asked Ms. Craig since she was a part of the Planning Commission if she knew why the Elkhorn Pass project was planning to have four and five-bedroom apartments, to which she responded that they will most likely be two-story structures, and with more people working from home, the demand for office space has increased.

#### <u>Supervisor</u>

Eddie Montemayor reports that the skate park is currently waiting for the new concrete to be fully cured, which takes about thirty days. He also follows up Ms. Miller's inquiry from last month's meeting regarding surveillance of the area, stating that there are currently cameras located there and that the Township will also be adding more.

#### **Treasurer**

Mike Dunckel reports that DDA investments have increased by 6,500 with a 4.5% interest rate. DDA revenue currently sits at 2.2 million.

Nancy Romig, 4168 Watson, states the condition of her road is poor, and requests the DDA to be apart of the Township's discussion in fixing local roads.

# 2025 Downtown Development Authority & Brownfield Redevelopment Authority Activities Informational Meeting for Taxing Jurisdiction

## Pursuant to Recodified Tax Increment Financing Act 57 of 2018 July 29, 2025

- Property at 2142 Cedar Street, immediately adjacent to the Holt Farmer's Market was added to 2150 Cedar Street to make one lot. The added space has dramatically impacted parking availability for the Market and the Cedar Street corridor. An Additional market building, which will double existing vendor space is beginning construction in 2025.
- The Holt Farmers Market will host seven Food Frenzies, and two BBQ and Brew events this summer and fall. Food trucks and live entertainment brings thousands of Delhi Township residents and visitors to the Cedar Street corridor.
- Operation of the year-round Holt Farmers Market, one of the Township's most popular destinations continues to expand. SNAP (EBT), Double Up Food Bucks, Senior and WIC Project FRESH coupons accepted. Repaving of the parking lot is scheduled for the last week of July 2025.
- Newsletter HoltNow, a publication highlighting local businesses is being changed to monthly, which is currently reaching over 14,000 people. Continued expansion of social media outlets (Facebook, Twitter, and Instagram) highlight Township events and local businesses.
- Eighteen additional flower planters have been purchased as part of the beautification plans for Delhi Township's Triangle Area.


